



**TIME OF USE
WHOLE HOUSE PLUG-IN ELECTRIC VEHICLE RATE
TOU PEV-2**

(Rate Code XX Super Off Peak - Rate Code 32 Off Peak – Rate Code 33 On Peak)

APPLICABILITY:

Applicable for service to single residences and individual family apartments taking service where Member owns a Plug-In Electric Vehicle (PEV). Qualifying plug-in vehicles should be manufactured primarily for use on public streets, roads, and highways. Electric scooters, electric bicycles, golf cars and motorized electric wheelchairs do not qualify.

AVAILABILITY:

Available as an alternative to RS-8 (Residential Service). There is no minimum commitment period. You can choose to sign up or un-enroll from this rate plan at any time. If you choose to switch from this rate plan to an alternate plan, you will not be able to make another switch for a full 12 months.

TYPE OF SERVICE:

Single-phase service, 60 hertz, at the following standard voltages: 120/240 or other voltages as might be mutually agreeable.

MONTHLY RATE:

Basic Facilities Charge:	@	\$33.00	per month

On-Peak kWh	@	\$ 0.22	per kWh

ON-PEAK hours are defined as the hours between 4:00 p.m. and 8:00 p.m. including all weekends and holidays.

OFF-PEAK hours are defined as the hours between 6:00 a.m. and 4:00 p.m. and between 8:00 p.m. and 10:00 p.m. including all weekends and holidays.

SUPER OFF-PEAK hours are defined as the hours between 10:00 p.m. and 6:00 a.m. including all weekends and holidays.

MINIMUM MONTHLY BILL:

The minimum monthly bill shall be the Basic Facilities Charge.

WHOLESALE POWER COST ADJUSTMENT:

The above rate shall be increased or decreased subject to the provisions of the Cooperative's Wholesale Power Cost Adjustment as set by the Cooperative's Board of Directors.

TERMS OF PAYMENT:

The above charges are net, the gross being ten (10) percent higher. In the event payment is not made within twenty (20) days from the date of the bill, the gross charges shall apply.

LOCAL TAX ADJUSTMENT:

The above rates are net of any applicable sales tax, excise tax, franchise, occupation, gross receipts or any other lawfully imposed tax, fee, charge or other imposition.

If any political subdivision of the state, or any taxing district collects such tax then, insofar as practicable, such payments shall be billed pro rata to the customer; provided, however, the foregoing shall not apply to ad valorem taxes.
